### Elzaan Coetzee Violin Studio's Privacy Policy

Your privacy is important to Elzaan Coetzee Violin Studio and your personal information is dealt with in terms of the Elzaan Coetzee Violin Studio Privacy Policy. ### 1. Use of information

#### 4. Information collection

The process of gathering the information as described immediately above uses a technology known as "cookies". #### 5. Sharing of information

Sometimes Elzaan Coetzee Violin Studio may share aggregated information (for example, demographic data) with its stakeholders and business partners, but it will not disclose your

personal information to third parties save with your consent or as provided in this privacy statement.

### 6. Collection of information by third parties

Owners or information system administrators of third party websites that have links to the Elzaan Coetzee Violin Studio website may collect personal information about you when you use these links. Elzaan Coetzee Violin Studio does not control the collection or use of personal information by third parties and this privacy statement does not apply to third parties.

#### 7. Clickstream data
